It's a vital service! New comers, members coming back, travelers – we all depend on accurate listings so that when we need a meeting, we can find it. This is one way we can fulfill our Pledge: Always to extend the hand and heart of OA to all who share my disease, for this *I Am Responsible*.

#### SHOULD WE ELIMINATE REGION 6?

What are we, besides an annual convention? Do intergroups need to participate both at a yearly WSBC and at regional assemblies?

Well, these are the questions that need to be asked. The Spring Assembly is the place to ask them. Our focus at the April 9, 2005 Spring Region 6 Assembly will be: What are we doing? What do we, as a Region, want to do? We will be having a strategic planning focus: an informal and open discussion of our value as a region, what we will want to do as part of OA as a whole, and how, or if, we want to accomplish them. We can look at some of the things we have accomplished the Public Information Blitz fund, which was intended to allow intergroups to do outreach projects they could not have otherwise afforded; the direct mailing of the R6 Messenger, and translation into French, which was intended to improve the way we get the message out in our

region. Now it's time to assess if these actions are producing the desired results. I hope we will have a good and vigorous discussion on April 9! The R6 Board will meet the following morning to make its own plan as to how we can best support the Region in accomplishing its goals.

#### **ACTIVITIES OF THE CHAIR**

Since my last report to the Region, I've traveled to the Region One convention in Calgary, Alberta, where the Region Chairs Committee met and then took part (as observers, mainly) in the Region One Assembly and Convention. I was terrifically grateful for the opportunity for the fellowship and recovery. Region One was reporting on its own strategic planning, and I heard a lot of very positive and helpful things. Theirs is a very active region and it was an inspiration. The Region Chairs Committee meets each year at one region assembly, and next year the chairs will be meeting here in Albany!

Last year I became Vice Chair of the Region Chairs Committee and as my good pal Charlene Lapierre's term was up last year, I will be serving as chair of that committee until we elect a new one in April.

I had a FANTASTIC time at the R6 convention in Hyannis – what a blast! I chaired a session on 4<sup>th</sup> Step writing, and had the usual anguish over picking which session to go to next. I was able to spend time soaking in the hot tub with old friends I haven't seen for ages, enjoy new friends at meals, have quality time with sponsees, and before you know it, it's time to go.

In terms of my own program: I have a sponsor in two different programs, I have two OA sponsees that I talk to every day and several others whom I am sponsoring through the Twelve Steps as laid out in the Big Book; am currently hearing a Fifth Step, and working Steps 10 through 12 daily; I am treasurer of my home group, the Needham Wednesday Night Beginners Meeting; am working on the upcoming MetroWest Intergroup retreat, and attend three meetings a week regularly, with others here and there. I follow a food plan that was given to me by a nutritionist, and am always asking God for help to keep my level of physical activity up, because it's harder in the cold weather, but it's so crucial to my threefold health! I try to do what I can, when I can, and I thank you for allowing me to do this service.

# TRUSTEE'S MESSAGE

Dear Fellow Region 6 OA Members,

Hello, my name is Dexter and I am a compulsive overeater. At my recent visit to the doctor I was 97 pounds less than when my abstinence began 13 years ago on March 22, 1992, through the grace of my Higher Power (HP). I had no higher power other than food when I came into OA. I found my HP through working OA's Steps with the help of a sponsor. Learning to listen to my HP has been an evolving process. I have discovered that my HP often speaks to me through my character defects and my disease. The necessity for a detailed inventory or for writing is brought to my attention when I start thinking about foods which are not in my food plan. This past holiday season has been unusual for me in that I have been more conscious of those foods from which I abstain. It started the day before Thanksgiving when I found myself remembering the old days when I would be shopping madly for pastry, liqueur and candies to round out the holiday HP reminded me that this kind of festivities. thinking is 'eating' thinking. After surrendering these thoughts to HP, my inventory revealed that I had buried grief that I wasn't going to be able to call mom as I always did on Thanksgiving because she died this past Easter Sunday. The thoughts of shopping disappeared as I felt the pain. My HP helped me through the holidays by continuing to bring me back to know my grief and helped me come to a new place in my understanding of my relationship to my mother and to a new place in my life. Inappropriate food thoughts and inappropriate emotional responses such as resentment or anger were the signals for surrendering to my HP and doing an inventory.

I believe this is another facet of my 'spiritual awakening' which is promised to me and to all of us in the 12th Step, "Having had a spiritual awakening as the result of these steps, we tried to carry this message to compulsive overeaters and practice these principles in all our affairs."

For me, this is the central miracle of the Steps, "spiritual aw akening". This awakening has given me my recovery, my freedom from the obsession with food, my 97-pound weight release. For me, it is also the central aspect of the First Tradition which tells us that, "Our common welfare should come first; personal recovery depends on OA unity." It is inescapable to me that we can all unite in the reality of our spiritual awakening as a result of OA's 12 Steps. While we may be anorexic, bulimic, male, female, lesbian, gay, believer, non-believer, young, old, in between or may follow different food plans such as no meat or no sugar, I believe we can all unite in the common solution to our problems, namely our spiritual aw akening as a result of the Steps.

For me, the 12th Step is also central to the Fifth Tradition which tells us our primary purpose is to carry the message. The 12th Step tells us what that message is, "...a spiritual awakening as the result of these steps...." I believe that when we depart from this simple message, we jeopardize OA unity and therefore our common welfare and ultimately our personal recovery.

The 12th Step also tells me why the 12th Tradition is so important. Since we have such a simple message, we have no need for stars or VIPs. We are all equal in the fellowship. Everything I state is my personal opinion and my opinion is no more or less important than anyone else's. If there are no stars or VIPs, we can be united as equals in our fellowship, united in our common goal of our own spiritual recovery, maintained through sharing it with others.

Chair — Zazu announces she is stepping down. Chip from Western Mass will be the new chair in 2005. Nancy from Queens Unity will be the secretary.

Minutes from Spring 2004 — We need to find someone who knows how to quilt. At WSBC, another region made a quilt to display; members of each Intergroup made pieces. Once we get the squares together, we can find a quilter. Region 1 raffled off a quilt at their convention. Need a quilt subcommittee to decide size of squares and type of squares. Nancy B. (Mid-Hudson IG) and Bill (Nassau County IG) will be on the quilt subcommittee. Chip (Western Mass IG) agreed to be on quilting subcommittee as chair of the general Intergroup committee.

Last Assembly people on the Intergroup committee e-mailed people from intergroups who have not attended in a while about coming to the Region 6 Assembly. The only response was from Suffolk County IG, which has a representative here today (Laura). Do we want to continue to contact the intergroups that don't show up to the Region 6 Assembly? Maybe we can compose a letter to be sent just to the intergroups that don't show up to the Region 6 Assembly. The Ad Hoc Communications committee met with the Newsletter committee because of broad common interests.

Elections were held for chair and secretary. Steve was elected chair and Raffaella was elected secretary.

A brief discussion of what went well and what we could learn from the production of the last new sletter was discussed. While most aspects of the editing, production and mailing went smoothly, there were important lessons learned and actions planned to improve the process for the next issue.

A large part of the meeting discussed production of a French language version of The Messenger. #### TWELFTH STEP WITHIN

Nineteen members attended the Twelfth Step Within (TSW) committee. We began with the Serenity Prayer. Judy C. (MetroWest IG) volunteered to be secretary. Four intergroups have requested more information about starting a TSW committee: Shirley B. from Ottawa area will contact Central Ontario; Cathy W. from NYS Capital District IG will contact Staten Island; and Kevin C. from Greater Rochester will contact Western NY.

Two-year goals:

- 1. Encourage intergroups to put on a sponsorship workshop.
- 2. Offer an R6 Assembly workshop on sponsorship at an Assembly.
  - 3. Present "meeting of month" to intergroups.
- 4. Motivate someone at a meeting to begin a relapse recovery meeting.
- 5. Present an OA Care Package to give information to those in relapse.

Five-year goals:

- 1. Put on a TSW project at the 2010 (50th anniversary) World Service Convention.
- 2. Encourage a TSW committee member to adopt an intergroup without a TSW committee

Cathy W. of NYS Capital District IG volunteered to update the Speakers List.

Gloria H. volunteered to write an article for Lifeline.

No chair came forward. A request for co-chair was made. No decision has been made.

The main problem with getting the message to young people is the lack of meetings and adult commitment.

Young people do not wish to be mothered; they want to be treated independently from adults.

Personal sharing talked about the need for flexibility of food plans and the need for sponsors to be flexible. It's important that those expressing the desire to work with young people buy into the theory of "love and tolerance is our code."

We want to get young people into OA and keep them here.

Young people have unique needs:

- Questions and answers can be permitted.
- Sitting still can be difficult.

Region Six Assembly - October 2, 2004

#### PUBLIC INFORMATION/HOSPITALS, PRISONS, INSTITUTIONS, MILITARY (PI/HIPM)

Tina, chair, opened meeting with Serenity Prayer at 12:40 p.m. Secretary was absent. Anne (Queens IG) volunteered to record the minutes. There were 23 persons in attendance representing 17 intergroups. This is the first meeting of the two committees combined.

Metro IG wanted to draft a motion to fund a PI new spaper blitz but was advised it was too late to propose at this Assembly. Reminder was made that any new proposals, particularly funding, must be submitted to committee, then passed on to the board for review and approval by February 1, 2005 to be presented at next Assembly in April 2005. Tina and Mark (Region coordinator) explained in detail the procedures followed when proposals are submitted: specifically, they must be presented committee, discussed, voted on and then passed to the board for similar review and approval before they may be presented to the Assembly for a vote. Reminder was made that PI/HIPM's budget is \$3,000 per Assembly (\$6,000 annually).

Review of previous PI/HIPM blitzes — Mark reported on results of the latest new spaper blitz in the Massachusetts area with excellent response. Ruth, Syracuse IG, advised that a magazine article devoted to OA would soon be on the new sstands. Michael, Bronx IG, reported cable TV would run OA video in Dec. 2004 and Jan. 2005. Carol, Westchester IG, noted that "Stepping Out," a syndicated AM radio program (which focuses on all 12 Step fellowships), interviewed four OAers. columnist was present at the interview and wrote an article about the program in a local new spaper. OA will be featured again sometime in October. Anne (Queens IG) is still getting calls on the intergroup hotline from previous free cable TV coverage. She reported that the cable company only gives free coverage for two months per year. Queens IG will need to purchase another video from WSO to imprint its new hotline telephone number in order to ask for

TV coverage again in 2005. Howard (NH IG) reported successful results of its HIPM blitz. Tina challenged all present to go back to their intergroups and get proposals for PI/HIPM ideas and bring them back to this committee for funding for next Assembly.

Review of strategic plans — two-year goals, results: Increase Region 6 Assembly attendances by 1 percent; current Region 6 Assembly seems to have an increase in attendance. Numbers are not available to substantiate. Fifteen intergroups have a PI committee or representative involved in PI w ork.

Motion made and passed unanimously to increase attendance at upcoming Assembly (with hope, by April 2005 and definitely by October 2005) by 10 percent. Members are asked to bring another intergroup member, particularly someone from the PI committee, to upcoming Assemblies as observers, thereby increasing attendance.

Review of strategic plans — five-year goals, results: At this committee meeting, there is one PI committee member from each of the 17 intergroups represented.

New goal is to reach out to other intergroups to offer guidance and support for PI/HIPM. A subcommittee was formed to write and present a motion, have it passed and then present it to R6 Assembly that would extend travel scholarship funds to cover expenses of PI representatives (not already funded delegates) to encourage them to attend R6 committee meetings. Nickie (Ithaca IG) will chair.

Election results — Tina, chair; Mary, co-chair. No secretary was elected; the post will be open to volunteers.

HIPM – David (MA) inquired about assistance needed with military outreach. All agreed that HIPM would be the first order of discussion at the April R6 Assembly.

Meeting closed with Serenity Prayer at 2:30 p.m.

#### CONVENTION

Ten members were present. Opened with the Serenity Prayer. Donna volunteered to be the secretary for this meeting.

- 1. Report from Cape Cod:
  - a. 440 registered for convention.
  - b. 164 rooms registered at hotel for a total of 324 people.
  - c. Five free rooms to date three speakers, R6 chair, raffle winner.
  - d. Program is on website.
  - e. Saturday tour 74 signed up; have a waiting list.
  - f. Account balance of \$11,837.00.
- 2. Report from New Hampshire:
  - a Presented merchandise will be available on Sunday at Cape Cod and for pre-ordering.
  - b. Committee consists of approximately 70 volunteers with 12-15 chairs.
  - c. Previewed a motion for additional seed money for printing costs for raffles, flyers, etc. that will be distributed at Cape Cod Convention.
  - d Motion made by Don for \$650 advance, seconded by Barbara, unanimously approved – will be presented to Assembly out of committee.
- 3. Proposal for future conventions discussed how intergroups could think about hosting a convention. Marie from Saratoga Springs will discuss with her intergroup.
- 4. Need to think about the timing of R6 Convention for 2007 as the World Service Convention will be August 29-31 in Philadelphia, near our region geographically but not part of our region. The suggestion was made to have the convention later than usual, perhaps mid-November.
- 5. Reminder that tapes from keynote speakers for 2005 convention need to be in by R6 Spring Assembly to convention committee chair need three years continuous abstinence; tapes need to be recent, made at an OA meeting to focus on OA experience and recovery, with the name, telephone number, and e-mail address on the tape.
- 6. Reviewed goals from last Assembly Pat S. and Don C. volunteered to work on R6 Convention Manual for fall of 2006. Discussed possible need for a budget line in the budget for Convention committee printing costs.
- 7. Chair position election Pat nominated Lee R. from Massachusetts as chair, which was seconded by Barbara. Lee accepted the nomination. Vote was unanimous.
- 8. Secretary position election Pat nominated Donna as secretary, which was seconded by Marilyn. Donna accepted the nomination. Vote was unanimous.

Closed with the Serenity prayer.

#### YOUNG PEOPLE (continued from p. 6)

- · Kids need rides to meetings.
- Parents purchase the food for young people; if the parents don't buy into the program, young people may not get what they need.
- Doctor's approval of food plan is a key component.
- It is important to refer to HP rather than God

There was some discussion about parents of the young compulsive eater:

- Parents should be discouraged from staying at the young person's OA meeting, so that young people will feel more comfortable to share openly.
- An open meeting could be held for parents so that members could explain OA to the parents.

Anonymity – this message should be communicated in simple language. Also, important stuff should be shared with sponsors. Help young people figure out what the important stuff is.

In order to start a young people's OA meeting, there should be a commitment from a responsible adult. Adult OA members will qualify at first, because young people will have nothing to qualify with for a while. Adult OA members would act as facilitators/teachers. ### **HIPM WORKSHOP NOTES**

#### Region Six Assembly - October 2, 2004

What follows are the group notes composed during the course of the workshop hosted by the Hospitals, Institutions, Professionals & Military Committee. It consists of lists of the actions taken and suggestions made by R6's various intergroups, HIPM intergroup committees and individuals which they have implemented in doing outreach work throughout Region 6.

#### **HEALTH FAIRS/PROFESSIONALS**

General practitioners and dieticians — members contact their own GPs and dieticians and send out brochures to these professionals. There is no way of knowing if new comers are recommended by these professionals.

Sent out packets through the Yellow Pages — not much of a response.

Health fair run by a local TV station — heavily attended. No way of gauging success because there is no way of telling how many new comers came to meetings.

Professional outreach — sent OA video to local cable stations and then held a general information meeting for new comers.

Lifeline magazine in doctors' offices.

Health fairs/Hospital Events and a Women's Prison (Western Mass IG)

Public Service announcements on local cable station (Queens Unity IG)

Health care — nutritionist in Plainview works with OA members and suggests to new patients that they go to OA meetings.

Went to a waterfront festival (Staten Island IG) — local cable company wants to set up an infomercial paid for by the local cable company.

Local county fair (Mid-Hudson IG) for Social Workers — they bring OA pamphlets.

Doctor in Western Mass Hospital tells patients to go to OA.

Religious groups — put a blurb in church new sletter about OA and got huge response.

#### UNNUMBERED GROUP A

Brainstorm ideas regarding reaching out to hospitals and institutions — one member from New York talked about inviting staff members of hospitals, assisted living centers and nursing homes, and health fairs.

Brooks noted that the Courier can be sent on-line to professionals and doctors' offices. If mailing the Courier,

postage is free as long as a moderate amount is mailed.

Obesity Centers — have open meetings.

Long Island Obesity Centers — not to be used as a quick fix program.

Marilyn talked about health fairs where no one was English-speaking. Three intergroups did outreach there.

Susan suggested sending or leaving small OA cards at doctors' and professionals' offices.

Eddie from Rockland/Long Island talked about putting cards up in supermarkets with a contact name and number on them.

Make face-to-face appointments with doctors, dentists, nurses — for not more than 20 minutes.

Leave pamphlets with an attractive holder at the nurses' station — with permission.

How ard talked about on the 12th of the month passing a basket with people's numbers so that they can be contacted.

#### **GROUP THREE**

Only one intergroup at our meeting has an official HIPM committee.

When they go to health fairs, they collect names of health care professionals who want further information and send out a mailing, which includes a letter, pamphlets, and a computer CD with OA info and OA members' stories.

Good ideas to introduce OA to the military — best points of contact are Army, Marines and Navy chaplains.

Correctional facilities — contact facility directly and ask who would be the best person to contact.

Great ideas — give literature to the local library to become part of the library collection.

Gear your attendance to age and type of population.

Addiction — held with different mediums — staff a table.

Speaking with own professionals

Health fair.

Leaving Lifeline — good icebreaker.

Physical placement inside a health fair.

Giveaways are good attraction.

Radio — 30-60 second scripts; TV — video from WSO; new spaper — phone number and OA website.

Gear info to audience.

Health fairs — we had a huge sign with the "15 questions"

and phone number. People who didn't approach booth stood back and took down phone number.

Health fairs — Channel 10 News sponsored. Big sign (picture of a very large plate with phone number). Booth was free.

Meeting and intergroups pooled money to pay for pamphlets and handouts; whatever was left was redistributed to groups. When professionals came by we handed "professional pamphlets" to them.

One open meeting every year for spouses and family – hand out flyers advertising it.

Go to street fairs. Got \$1.5 million free ads on TV cable (donated by cable service providers). Did need money to make copies of tapes.

OA got phone call from church that wanted to start a meeting at the church — they can't do it but we did present a panel. The outcome was that a meeting was started. We helped church out but not the way it had planned.

Project — to reach out to troubled teenagers by purchasing beginner packets and giving them out.

Offer professional packets to personal health care providers.

Call from health fair — OA invited. Northeastern University called and asked for "packets."

Ask to leave OA business cards in establishments wherever you go.

Going to bariatric units and fitness facilities and leaving pamphlets; starting to go to institutions that work with anorexics and bulimics.

Freebies work!!! Waterfront festival — put up big banner with phone number and gave out magnets (purchased by several groups to diffuse cost). On list of referral center on college campus. Going to senior citizen centers. Going to open houses at colleges. Going to grade schools. Attending PTA meetings.

Bring before and after pictures wherever you go and wherever you present.

Fairs covered by media — make sure your face is not shown (take picture only of booth or with people with backs turned).

Most of the things that can be copied are on intergroup (or WSO) website.

#### Acceptance Is The Key

A cceptance will be the key. I have to look at this key and see what it looks like. It is not always easy to find but it is easier to handle than I imagine. Many times I take the key of judgment first and try to use it to open the way through a tough situation. But the door that key opens is a door to trouble. It is warm in that room of judgment. What starts off feeling like the warmth of correctness quickly turns into burning stress and upset.

W hile the key of judgment is bigger and easier to find, it opens to me a small, hot room. Instead, the key of acceptance opens a door to all of life. Through that door of acceptance I can begin to see life as it really is. And I can let it be what it is.

Through my upbringing in an organized religion, I was given judging keys for every pocket I had. The acceptance key came when I accepted God as someone who accepted me as I am. If I use this key often enough, I will become more familiar with it and will want to get rid of all those other keys and just keep the acceptance key in my heart where I can never misplace it.

That acceptance key is also the key through my past hurts. Where I find guilt, shame and remorse, I can with tender love open those doors and look in again and accept what happened as just what happened. I cannot change it. I cannot today go in and rearrange that room. That room is forever frozen in time and I can only see that room as a painting on a wall. Whether I like it or not, it no longer matters, because all these "paintings" make up the museum of my life. Acceptance is the key to the present, the past and the future. With that key I can face all situations with a serenity beyond anything I have ever imagined.
