# FROM THE REGION 6 CHAIR

Attending the World Service Business Conference for the second time as the R6 Chair really taught me how very different each experience at World Service can be. Last year, since it was my first time attending as the R6 Chair, I could barely manage to keep my head on straight.

At WSBC 2013, with a year's experience as the R6 chair and having fully participated as a member of the Region Chairs Committee, what came into full focus for me was how very important and VALUABLE our *differences* are. What we have in common, that we are compulsive overeaters, is what brings us together. However, in making OA the successful, functioning organization we are, it is the integration of each of our unique skills and experiences which allows OA to actually carry the message to all those who still suffer.

This appreciation became very clear to me in working on the Fellowship Inventory. Last year, when the Board of Trustees first presented the Region Chairs Committee with the theme *Searching and Fearless: A Fellowship Inventory* for WSBC 2013, it was all I could do to keep from rolling my eyes. I anticipated an entire year of boredom. What was really going on was an acute case of contempt prior to investigation.

The skills of my fellow Region Chairs and their ability to craft a series of questions, to patiently ask for and receive feedback through a series of pertinent questions which would really get to the heart of what OA was doing well (and what we were not) were tasks which I could never imagine myself doing. But I did not have to, as there were other members who could and would, gladly. When my feedback was asked for, *and only if I had something of value to contribute*, I did.

For OA to have a clear and accurate picture of where the organization stood, we would need some clear, hard data. When it came time to crunch the numbers that arrived as a result of the survey, I am grateful for the members willing to do this service.

I had taken on the job of writing the parody song which would introduce the Forum. The song was the simple part. But I wanted to make it approachable and entertaining. So, over the course of a few months, during the late nights when I could not sleep due to the many tumultuous events which were taking place in my life, I worked on the PowerPoint presentation. Researching the music, getting the lyrics to match the rhythm of the music, all of it was a pleasurable challenge and something I was looking forward to sharing with my OA fellows.

When the script for the Forum skit had been circulated the ideas and characters were clear but my instinct said that I should "punch it up." It just needed some pizzazz and chutzpah, y'know, a little snappier dialogue to convey what was goin' on.

My specialty! It was only at the very end of this project where my participation was required and my set of skills was needed. The entire project was directed by Higher -Power and not me.

For WSBC 2013, I also served as Coordinator of the Green Dot/Mentor program. It gave me the opportunity to communicate with and pair OAs from all over the world with one another.

I am also very pleased to report that as of this writing, six R6 Intergroups have held or plan to hold Sponsorship Workshops, made possible with funding from Region Six.

Regarding the Public Information (PI) Blitz funding, since the advent of the workshop on applying for funding, R6 has seen many more first-time applications from intergroups. This is very positive. One of the other effects, however, is that some applications for projects submitted by first-timer intergroups have been incomplete, off-target or requesting funds which are far beyond the R6 budget. As a reminder, the focus of PI Blitz projects needs to be about informing the general public or professionals and institutions working with compulsive eaters about our program. The target must be specifically within an individual intergroup's geographic area; currently R6 allocates \$4000 per assembly, a total of \$8000 per year, to be divided among ALL of the R6 intergroups that are applying.

# FROM THE REGION 6 TRUSTEE

My name is Karin and I am grateful to be serving as the Region 6 Trustee. I was elected as R6 Trustee at the WSBC in May after being appointed for 5 months. Even though I ran unopposed, I was nervous, standing there speaking in front of approximately 200 abstinent delegates. It has taken some time for me to get settled in and learn all that is involved in being trustee and I am happy to be doing this service. I was told that serving as trustee would change me and that I wouldn't want to miss this opportunity. I am doing things out of my comfort zone and learning so much.

The trustees are the guardians of the steps and traditions. A tall order I think! I believe we all have a responsibility to guard the traditions, to speak up when we see or hear something that is not in harmony with the traditions. Honoring the traditions ensures the survival of our groups. They provide the principles that keep groups strong and healthy – which is vital to the growth and life of OA. It begins with the first tradition. "Our common welfare should come first; personal recovery depends upon OA unity."

This emphasis on unity is one of the greatest assets of our fellowship. Our lives depend upon it. If we are to continue to live and recover from compulsive eating we must have the continued support of our fellow members and OA groups where we have found acceptance and a sense of belonging. If the unity of the group is jeopardized, it may cease to thrive and could very easily fall apart. Individual members may drift away and leave the program. As it says in the *Twelve Steps and Twelve Traditions of Overeaters Anonymous* on page 110: "The unity of OA is a matter of life and death to us." We can't recover unless there is a group. We need each other and the group to survive. Strength comes from the union of many. Together we can do what we cannot do alone so we need to place the welfare of the group above our own personal desires.

Tradition one also tells us to focus on our similarities, not our differences. There is room for more than one approach to recovery. Love and tolerance is our code. Our focus needs to be on what we have in common - the solution. Our source of unity is that we are all working the Twelve Steps of recovery.

As trustee I receive many inquiries and tradition questions from members in Region 6. Some examples are: Can an OA group display/use or sell non OA-approved literature? Is it ok to leave a cell phone on speaker at a meeting so another member who is not present can hear the meeting? Can we read the AA Promises from a typed sheet of paper at an OA meeting? Is it possible to have a perfume-free meeting? What is the philosophy of OA regarding people obtaining assistance with medications to control binge eating? Can a registered OA group use the AA Joe & Charlie Tapes or the Back to Basics format as the basis for a meeting? How to handle a disruptive member at meetings? What is the role/impact of AA literature in OA? Contact me if you are interested in responses to any of these questions.

There were 207 delegates at the WSBC this year, 33 of them from Region 6. We made informed decisions for the good of OA as a whole. We approved one piece of literature: **For Today, e workbook.** 

The delegates also approved a change of wording for the OA Preamble:

"Our primary purpose is to abstain from compulsive o<del>ver</del>eating and to carry this the message of recovery through the <u>Twelve Steps of OA</u> to those who still suffer."

I hope to see you in Cleveland, Ohio for the 2013 World Service Convention; Recovery to Rock our World, August 29-Sept 1. It will be a great event, so if you are able, make plans to attend.

I am committed to abstinence and this program of recovery. OA's theme for 2013 is the Year of Abstinence Awareness. I wish you all the gift of abstinence, one day at a time. It is available to all of us and it works!

Thank you for allowing me to serve the fellowship.

### **Opening Prayer/Welcome**

Region 6 Chair Diana G. opened the R6A at 9:50 am with the Serenity Prayer and then Carmen D. recited it in French. The Twelve Steps, Twelve Traditions, and the Twelve Concepts were read

**Roll Call** – The total number of registered delegates was 57 plus 6 board members with a total of 63 eligible voters. Simple majority is 32 and 2/3's majority is 42.

**Introduction of officers/former officers** – Chair Diana G. introduced the present R6 Board members and had previous board members stand and introduce themselves.

**Introduction of Service Volunteers** – There were nine service volunteers.

**Introduction of New Representatives** – There were 12 new representatives.

Power Point presentation of former Trustee Mary Rose D. was shown. She passed away on December 27, 2012.

Officer Reports – given by Chair—Diana G.; Vice Chair—Debbie H.; Treasurer—Kelly C.; Coordinator—Tobi H.; and Website and Publication Coordinator—Devyn C.

**Committee Reports--** Each committee chair came to the front of the R6A and gave a three minute synopsis of their report. Full reports will be available prior to the fall 2013 Assembly at the R6 website.

**PI Caucus--** The board discussed recommendations from the PI Committee and decided to award PI Blitz funding to: NYC Metro- \$1600.00, Ithaca-\$1150.00, Suffolk- \$2225.00, and West. Mass.- \$380.00.

### **NEW BUSINESS**

### Motions-

Motion #1: Passes-Amend the current policy and procedures to allow the Website and Publications Coordinator to maintain the R6 speakers list.

Motion #2: Passes- Protect ownership of R6- owned recordings.

Motion #3: Passes- Provide a way for the R6 board to elect a chair to a committee if the individual

does not meet the requirements.

Motion #4: Passes- Provide funds to IGOR committee to coordinate a comprehensive training

session for IG Chairs.

Motion #5: Passes- Allow the minutes to be distributed within thirty (30) days of the Assembly

to the Chair and Coordinator.

Motion #6: Passes- Incorporate policy wording around e-mail addresses on the R6 website to

protect anonymity.

Motion #7: Passes- Give the Region 6 Board permission to investigate a place to hold the Fall R6A.

### **COMMITTEE MOTIONS--**

PI COMMITTEE: Passes- Motion that the 2013-2014 OA Region 6 Budget be increased by \$485.00 to sufficiently fund request for PI Blitzes.

CONVENTION COMMITTEE: Passes- Motion to hold the 2014 R6 Convention on October 24-26, 2014 in Greater Boston, Mass.

Finance: Passes- Motion to adopt 2013/2014 budget.

Schedule: Passes- April 18, 2015 Spring Assembly; September 28, 2015 Fall Assembly.

**Workshop--** Sponsorship workshop was lead by Karin H. and Susan P. The first ten IG's which hold a Sponsorship workshop, provide fliers with the R6 logo, and post their event on the R6 calendar will receive reimbursement from R6 for up to \$200 worth of expenses.

Lifeline Raffle- Was won by Carmen D.

**First Timers Ceremony**– Chair Diana had all first timers come to the front of the room. They were asked to remove their blue dots. Officially they are now old timers.

The meeting was adjourned at 5:55pm by Chair Diana G with the Serenity Prayer.

# **Getting Started in Public Information Work**

One of the most important functions of any OA intergroup is to carry out public information (PI) activities. After all, an intergroup's purpose is to do the *common* business and service work of its member groups. And carrying the message to those who still suffer from our disease is our primary purpose!

If you are part of a large intergroup, you may already have a committee doing this work. If, however, you have a smaller struggling intergroup, and you've never done this type of service work before, you may be asking how to get started.

One of the best places to start is OA.org (<a href="http://www.oa.org/membersgroups/public-information-suggestions">http://www.oa.org/membersgroups/public-information-suggestions</a>). Here, you can find sample press releases and posters that you can tailor for local use: community health fair ideas, press and advertising examples, public service announcement tips for radio and TV stations (WSO has already done all the production work for 60-30- and 15-second spots! You just have to buy them for your local stations), and many other ideas. OA also publishes a PI service manual which contains a wealth of information.

Our small-town intergroup has used several of the professionally designed 8x11" posters that OA provides, in order to create "tear-sheets", which we put up on community bulletin boards. A potential member can tear off a section of the bottom of the sheet bearing the OA website and local hot-line number. This is an inexpensive and effective way of "carrying the message". Also, it costs nothing to have the times and locations of our meetings listed in the newspaper calendar section. We also maintain a local phone line which features a short explanation of OA, a list of our weekly meetings, and the contact information for some of our members.

Region 6 also has had a number of creative proposals for their "PI Blitz" awards in past years. Intergroups with great ideas and short funds can get help from Region 6 by filling out a proposal (see <a href="http://oaregion6.org/wptest/wp-content/uploads/2012/02/R6\_PIBlitz\_Request02192012.pdf">http://oaregion6.org/wptest/wp-content/uploads/2012/02/R6\_PIBlitz\_Request02192012.pdf</a>) and submitting it to the region coordinator in advance of the biannual R6 Assembly. Some of these have included: OA ads on restaurant placemats, ads on inserts sent with utility company bills and in newspapers, posters at high-traffic suburban train stations, and on the exterior of transit buses.

On the same OA.org web page, you can sign up to get, or be, a PI mentor. This new WSBC program aims to match up those service bodies which have had successful outreach and information campaigns with those seeking guidance. What a great idea!

One important reminder: If you are going to use the OA logo on any of your materials, you need to obtain permission from WSO first. See <a href="http://www.oa.org/membersgroups/copyright-requests/">http://www.oa.org/membersgroups/copyright-requests/</a> for more information.

# PI/PO COMMITTEE REPORT

Chair—John O., Secretary—Evan L.

### Issues discussed:

- How many email "touch bases" the committee should have between now and the next meeting.
- All Blitzes were reviewed and discussed.
- Reviewed Seacoast's proposal. However, their project was incomplete, it was not approved, and Seacoast will be asked to complete their proposal.
- Status reports from previous awards to South Eastern CT Intergroup and Nassau IG are needed.
- We need a list of previously successful PI blitzes and a short guide to show how to submit a proposal. Suggested that an article to this effect be written for The Messenger. Beth C. suggested there needs to be more online advertising and outreach.

### **Decisions made:**

- Focused on the reasons why the current members of the committee were interested in Youth in OA. Some information from AA was provided on how they communicate with teens and it will be reviewed.
- Discussed particulars of a youth-focused meeting in which a member from NYC is involved, how it was started, and how it is progressing. This member will send out the meeting format to help us bring this information to our IG's.
- Discussed a PI blitz focused on Professionals and Youth at one member's IG and we will get information on that as well.

# FINANCE COMMITTEE REPORT

### **Issues Discussed:**

- Reviewed statement of purpose, policy and procedure for the R6 Finance Committee.
- Reviewed the annual budget.
- 15% of net amount from the Ottawa Convention was sent to WSO.
- Many of the committees are not spending the money that has been proposed.
- Prudent reserve is in Money Markets accounts (\$20,000)
   Some of the groups' proposed budget has been lowered due to the fact that not all of the allocated funds had been spent during the previous year.

### **Decisions Made:**

- Motion was made to accept guidelines as agenda for today's meeting. Motion passed.
- A motion was made to approve the amended budget, April 20, 2013. (The proposed budget for the Officer travel – Assembly was changed from \$4200 to \$4250). Motion passed.
