297 Intergroups
15 National Service Boards
11 Regions
3 Language Service Boards
2 Specific Focus Service Boards

Intergroups: Intergroups are composed of several groups meeting in an area or online that realize they can better perform together rather than separately. Intergroups are directly responsible to the groups they serve.

National Service Boards: National service boards are composed of groups and intergroups who share a common purpose; to deal with issues that require a combination of membership and financial resources of intergroups and groups established within a single country. Currently, there are 15 NSB's: Israel, England, Brazil, Italy, Spain, Iceland, France, Sweden, Denmark, Poland, Greece, Venezuela, Islamic Republic of Iran, Latvia, Russian Federation.

Regions: Regions are composed of groups, intergroups, and service boards within specified geographic boundaries and the virtual community. **Currently, there are 11 Regions.**

Language Service Boards: Language service boards are composed of groups, intergroups, and national service boards to serve the common needs of a language group, regardless of geographic proximity. Currently, there are three LSB's: Deutschsprachiger Dienst Der OA (Germany), Japan LSB and Junta de Servicio del Idioma Español (United States).


Specific Focus Service Boards: Specific-focus service boards are composed of two or more groups or intergroups to serve the common needs of groups and intergroups with the same specific focus, regardless of geographic proximity. **Currently, there are two SFSB's: Secular and Rainbow (LGBTQ+).**
